If at any time, for any reason, the Company Applicant fails to pay for purchases when due, the Company Applicant agrees to pay and authorizes Interstate to bill our account for interest computed at the rate of 10% per annum or the maximum amount allowed by law whichever is greater. In the event it becomes necessary to incur collection costs or institute suit to collect any amount due under this Agreement or any portion thereof, the Company Applicant promises to pay such additional collection costs, charges and expenses including attorney's fees pursuant to this contract or CCP 1717.5 whichever is greater.

For good and valuable consideration which is hereby acknowledged, which includes, but is not limited to Interstate selling goods or continuing to sell goods and merchandise to Company Applicant, I/We the undersigned are signing this Agreement in two capacities, both for the Company Applicant and as individuals. I/We, the undersigned, in our individual personal capacities, by this Agreement do expressly personally, unconditionally, jointly, severally, irrevocably and continually personally guarantee to pay the indebtedness of the Company Applicant to Interstate for all past and future goods and merchandise purchased by the Company Applicant. In doing so, I/We the undersigned expressly warrant and represent that I/We have read and understand this entire agreement and it is our intention by signing this Agreement to personally guaranty and assume joint and several responsibility to Interstate along with the Company Applicant for all past, present and future purchases, debts and obligations due from Company Applicant to Interstate.
